Terms and Conditions

Agreement between User and symmetrylending.com

Welcome to symmetrylending.com. The symmetrylending.com website (the "Site") is comprised of various web pages operated by Symmetry Lending, LLC ("Symmetry Lending"). Symmetrylending.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Symmetry Lending does not distribute the home equity lines of credit available from all lenders in the marketplace and cannot guarantee the lowest fees or the best terms available in the market. Symmetry Lending does not charge consumers a fee for its services. Symmetry Lending is paid a fee by the Lenders for the goods, facilities and services provided by Symmetry Lending during the processing, underwriting, and closing of the loan. The Lender does not pass the fee on to the consumer.

"Cookies"

When you visit the Site, Symmetry Lending collects certain non-personal data by various means, one of which is "cookies." A cookie is an alphanumeric string of text (a unique identifier) that our web-server stores in your computer by means of your web-browser.
